ASSUMPTION OF RISK AND RELEASE FROM LIABILITY

VOLUNTARY PARTICIPATION IN EQUINE ACTIVITIES

1. I, _____, acknowledge that I have voluntarily applied to participate in certain recreational activities, including without limitation horseback riding, shooting, dirt biking, at the premises of Reed Valley Ranch, located at 36521 Reed Valley Road in Hemet, California. I understand that horseback riding is a dangerous and hazardous athletic event and a horse environment poses potentially serious risks of injuries to it's participants and/or observers. I understand that I, or my minor, may be injured as a result of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I, or my minor, am going to be engaged or observed. I also understand that horses, even the most well-trained, are often unpredictable and often difficult to control, and that no one has represented or stated to me that horses within the common environment are "safe" or "quiet" or have any specific or particular qualities
